# What is a GSR and Why Should I Care?

"The strength of our whole A.A. Service structure starts with the group and with the general service representative (G.S.R.) the group elects. I cannot emphasize too strongly the G.S.R.'s importance." – Bill W.

As a newcomer, I knew I had to do everything differently in order to maintain my new found sobriety. I was told to find a home group; so I did. I was told to get a position in that home group; I was elected to be the GSR. The what?

To someone who has no clue about the service structure of A.A., the bombardment of acronymns and legal terms found in the *General Service Manual* can seem as baffling as our common disease, but this is where the experience of AAs service seasoned members comes to the rescue. One of the most important things I was told as a newcomer in general service is "Don't worry. Ask questions. We were all new at one time."

The General Service Representative (GSR), I found out, is a vital link between the AA group and AA as a whole. I was responsible for attending my District Committee meeting, where other GSRs from groups in my district would meet and share the experience and opinions from our group's members. The District Committee Members (DCMs) act as officers for this committee and represent the whole district at the state level at Area Assembly. As a GSR I also attended Area Assembly and voted on important issues in AA for my state. The Area Delegate then takes the group conscience from the GSRs, DCMs and Committee Officers from our Area to the General Service conference, where the decisions are made for AA throughout the world.

What I really found, though, was a way to be useful in my new life that connected me to the fellowship of AA. I became surrounded with people just like me, who came from the threshold of death's door to a life of meaning and purpose, possessing a love and respect for Alcoholics Anonymous that made us want to serve our fellowship and make opportunities like the one that saved my life possible for other suffering alcoholics who have not yet made it home to AA.
